SHORT TERM FUNDING - TIMELY GRANTS

United Way of Knox County is pleased to offer a community grant program that provides short-term funding to projects and initiatives that aim to improve the quality of life for Knox County residents. As with all United Way funding, programs applying for timely grants must fall into one of our focus areas:

Youth opportunity and educational enrichment

Financial stability for families and individuals

Access to healthcare, particularly for at-risk populations

Community Resiliency – address specific community-wide issues with priority given to prevention of and treatment for substance misuse and prevention of and recovery from domestic violence

Short-term funding through Timely Grants is meant to support one-time efforts such as capital projects and pilot programs, or to introduce new agencies to the United Way funding process. For this reason, a single program or initiative cannot apply for more than two (2) Timely Grants without special board permission obtained through the Executive Director.

Application Requirements and Process

Applications for Timely Grants are accepted throughout the year. Our Community Investment Committee meets bimonthly to discuss applications and make recommendations to the United Way Board of Directors.

All funding decisions are finalized by the Board of Directors.

To be considered for funding in 2025, applicants must:

- Be affiliated with a 501(c)3 nonprofit
- Use grant funding to serve Knox County, Ohio residents only
- Demonstrate a specific community need and a plan to address said need
- Adhere to principles of inclusivity and diversity that align with United Way's diversity, equity, and inclusion statement

- Promote political campaigns or candidates for public office
- Promote specific and/or exclusive religious activities or beliefs

Programs that demonstrate collaboration among community partners will receive priority funding.

Reporting Requirements

Recipients of United Way Timely Grants are required to publicly acknowledge their partnership with United Way. The United Way logo may be used in formal publications and promotional materials to highlight this collaboration.

Program Data: Recipients must submit follow-up program data within 60 days of the grant period's end. This data should include measurable outcomes and an assessment of the program's impact.

Photographic Evidence: Recipients must provide a minimum of three high-resolution photographs showcasing the program's activities and outcomes. These photographs should be submitted within 60 days of the grant period's end. All photographs submitted to the United Way of Knox County may be used for promotional purposes and should only contain individuals who have given written media consent to the grant seeking organization/individual.
